NEW BUSINESS

Revisited the meeting dates. Although a set date seems ideal it may limit us on those who can attend. It was decided at this meeting to test hosting the **next meeting on Wednesday June 14**, so future meetings will be **alternating the second Tuesday or Wednesday of each month.**

Historically the Capitaliers meet in the months of April, May, June, October, November and December and there is no meeting in September due to the annual event hosted by The Forerunners. There was discussion at today's meeting to add September. Will need to review this with the group for certainty at the next meeting.

No decision made yet on a permanent meeting location. Continue to look for a more centralized location or alternating locations to accommodate those members who live outside of the Lansing area. In April these locations were discussed: One North-West Side, Reno's East-East Lansing, Royal Scott-Northwest Lansing, Tony M's Southwest Lansing and Flap Jack-Dewitt. The location needs to include a private area for lunch/meeting. Enough to accommodate approximately 30, depending on future turn out and be able to provide a couple lunch options. As of today's meeting, awaiting a call back from Tony's Ms. Flapjack in Dewitt has a small room which may not be sizeable for a larger group. Dewitt VFW was discussed; however, they charge for the room and do not provide meals. For now, Delhi Café will be the next location for June unless we can secure another option.

This month's meal options were a Gyro with choice of fruit or fries or attendees could choose a Chef salad. The lunch was \$15.00 a person and includes drink and tip.

Helen Riendeau shared information regarding The Forerunners. She collected \$10.00 membership dues and provided an update on the scholarships. There are 7 \$1000 and 2 \$800 scholarships. Your membership secures an invitation for the annual September event which will be on Wednesday September 13. You are responsible for the price of your meal.
