## AGENDA

President Kathy Gabriel called the meeting to order at 11:30 am.

The Secretary's Report from the April 19, 2023 meeting and the Treasurer's Reports for the quarterly periods April 1, 2023 – June 30, 2023 and July 1, 2023 - September 30, 2023 were reviewed. Motions to have them accepted as submitted were passed. It was suggested that the Forerunners' could get better interest rates than 0.8% on the CDs. Kathy will review this with the Consumers' credit union in Jackson who holds our accounts.

Joann Davis gave an update on the Fall/Winter Retiree Newsletter which will be out shortly. All Forerunners' members get either a paper or the less expensive email edition. There is a need for more news from the local chapters. There will also be mention of the 2024 Scholarships (see below). The Retirees' Web site is getting improved. Kathy and Nora Brezinski will meet with Miles from Consumers' IT on October 23<sup>rd</sup> on how to update the files from Fidelity.

Kathy reported that the Annual Golf Outing had 108 golfers. The food at this facility (Hawk Meadows in Howell) was "awesome" and the course was nice. It is requested that if anyone has a suggestion for next year's golf outing, to please let Kathy know. Kathy also reported that the Annual Luncheon, held at the Cascades Manor House in Jackson, had 98 attendees. Consumers Energy CEO Garrick Rochow was the Guest Speaker and he also took questions from those attending, including on the topics of solar energy and windmills. The entertainment singer was well received. Suggestions for next year's luncheon are welcomed. Some ideas proposed during the meeting include Meijers' Gardens in Grand Rapids, Southern Exposure in the Battle Creek area, Waldenwoods Resort (Hartland, MI), Red Poppy (?), and Meadowbrook in Rochester, MI.

The 2024 Scholarships were discussed. It was decided that due to the state of our finances, we could increase the past 2-\$800 scholarships to \$1,000 each. Consequently, we will offer 7-\$1,000 scholarships in 2024. Assuming Richmond Insurance and Flynn Wealth Advisors will continue to sponsor \$1,000 each, the Jacksonians will support 1-\$1,000, the Annual Events (Golf & Grill Luncheon) 1-\$1,000 and the Forerunners' Building for the Future 3-\$1,000.

Vonda presented that the Forerunners' Bylaws need to be amended to NOT offer Life-time membership to members. This had been discussed and proposed at a previous subcommittee meeting. Helen and Rhoda presented the motion which passed; one vote against it. Reports from Local Chapters: Cheryl Adams requested financial assistance for the local chapters with their administrative expenses. She reported that the Metro Pioneers have \$1,300 in their budget, but they have to do 3 US mailings/year to 55 members who don't have email.

After a quick survey of other chapters, Al Morgenthaler reported that the Adrianites only have \$250 in their budget.

Tom Bollman indicated that the Flint group is still able to mail their materials through the Consumers service center.

It was suggested that those chapters needing help, to let Kathy, Vonda, or Helen know. Gerry Letson of Bay City reported that their meeting was moved from September to October, so he had no news.

Joann Davis reported that the Jacksonians would be having a wine tasting event on October 17th, for which they invited other chapters to attend.

Due to various reasons, Lansing, Livonia/Howell, South Monroe, and Grand Rapids chapter representatives could not attend today's meeting. In addition, there are several chapters who no longer have anyone willing or able to take on leadership roles, including Alma, Traverse City/Northwest, Muskegon, and Kalamazoo/Battle Creek.

Our next meeting will be Monday, April 1st at the Monroe Grill. See you then.
